GREETINGS:

I wish to participate in the Pool of Defense Attorney in your office in this Jury District and I respectfully request that my application be entered in the Raffle Box Pool in your office for the participants.

A: I CERTIFY that:

- 1. I am a bonafide member of the Integrated Bar of the Philippines. My Bar Number is _____.
- 2. I am engaged in the private practice of law actually for ____ years as of the filing of this application.

3. As of the date I filed this application, I have devoted at least 24 hours of self-study of the Rules of the Jury System. I have read the entire Rules of the Jury System. My study included a personal "dry run" preparation of both forms for jury trial instructions, Form TJ-109, Form TJ-110 and Form TJ-111 and other forms closely related with said forms. My accomplished "dry run" forms in my own handwriting are herewith attached. In filling up the forms, I took turns in assuming the different roles of the presiding judge on the parts to be accomplished by the judge, the prosecutor for the parts to be accomplished by the prosecutor, and the defense for the parts to be accomplished by the defense counsel. I likewise took cognizance of the rudiments in the filing of grand jury indictments with reference to the requirements in Section 5(o)&(P), Rule 1, and the empaneling and peremptory challenges of the jurors in Section 16, Rule 3, of the Rules of the Jury System.

B: I PROMISE and WILFULLY AGREE that:

(1) I shall accept an assignment to defend an accused before a bench court or a trial jury of the type of cases I have specified on the outside of my application for Defense Attorney's pool membership that may come up for trial at least twenty (20) calendar days before the trial commencement date provided that I shall have the option which I shall notify the Public Attorney's Office that I must exercise within five (5) calendar days from receipt of my nomination but not after the said twenty-day period begins to avoid obstruction of justice, to refuse an assignment on account of close family ties or friendship, prior confidential social dealing, business or official transaction with the accuser or complainant in this case.

(2) I shall keep this matter strictly confidential; and

(3) I shall accept compensation on per diem basis starting with one non-trial day to prepare for trial and for each day that I appear in court as a defense attorney on a case for trial under the Unconditional Non-Transferrable Redeemable Judicial Voucher prescribed in Form GJ-26, at the rate of pay equivalent to the hourly compensation of the last appointed regular prosecutor of the province or city where I shall serve.
