As a member of the Grand Jury, you are required to act with sovereign dignity directly, pursuant to Article 2, Section 1, of the Constitution, in behalf of the sovereign people you are representing and you must deal with him as your subordinate public servant regardless of his rank, title, position, nobility or royalty.>
